TERMS AND CONDITIONS

PRELIMINARIES

- (A) Celtic FC Foundation, a registered Scottish Charitable Incorporated Organisation with the Office of the Scottish Charity Regulator (number SC024648) and having its place of business at Celtic Park, Glasgow G40 3RE ("Celtic FC Foundation").**
- (B) Mary's Meals, a registered charity in Scotland with the Office of the Scottish Charity Regulator (number SC022140) and having its place of business at Craig Lodge, Dalmally, Argyll PA33 1AR ("Mary's Meals").**
- (C) Wild Fox Events, a company registered under the Companies Act (number SC199793) and having its registered office at Jeffrey Crawford & co Chartered Accountants, 25 Castle Terrace, Edinburgh EH1 2ER ("Wild Fox Events").**
- (D) The following terms and conditions apply to participants in the Celtic FC Foundation 'Miles for Meals' fundraising event, a three-day trek from The Shed, Dalmally to Celtic Park, Glasgow (the "Event") starting on Thursday, June 9, 2022 and finishing on Saturday, June 11, 2022 (the "Event Date"). Please take time to read these carefully as you are bound by them, on receipt by Celtic FC Foundation of your deposit.**
- (E) Celtic FC Foundation will reserve places and deliver the Event, with Mary's Meals and Wild Fox Events acting as delivery partners (the "Delivery Partners"). For the avoidance of doubt, Celtic FC Foundation shall not be liable to compensate you for any damage or loss resulting from the negligent act or omission of any other person, including Mary's Meals and Wild Fox Events, its employees, contractors and suppliers.**
- (F) All monies will be managed by Celtic FC Foundation and the net proceeds of the monies raised – following payment of all expenses – will be split evenly between Celtic FC Foundation and Mary's Meals for delivery of their charitable activities.**
- (G) By registering for this Event, you are agreeing to the following conditions of entry and any instructions given to you by Celtic FC Foundation and/ or the Delivery Partners.**

Celtic FC Foundation is a registered Scottish Charitable Incorporated Organisation, number SC024648.

Mary's Meals is a registered Scottish Charitable Incorporated Organisation, number SC022140.

1. Event Details

- (a) Each participant will undertake a three-day trek from The Shed, Dalmally to Celtic Park, Glasgow delivered by Celtic FC Foundation with help from the Delivery Partners.
- (b) The Event is scheduled to start on Thursday, June 9, 2022 and finish on Saturday, June 11, 2022 (the “**Event Date**”).
- (c) You must arrive at Celtic Park on Thursday, June 9, 2022, at the time advised by Celtic FC Foundation.
- (d) Celtic FC Foundation and its Delivery Partners will provide the following transport arrangements for the Event:
 - i) a coach to transport participants to The Shed, Dalmally from Celtic Park on **Thursday, June 9, 2022;**
 - ii) a support vehicle to transport participants and equipment when required during the Event; and
 - iii) two safety walkers to accompany participants on each day of the Event.

All transport arrangements are subject to change should climatic or any other unforeseen circumstances deem this necessary.

- (e) Celtic FC Foundation and its Delivery Partners will provide the following accommodation and food arrangements for the Event:
 - i) accommodation will be provided on a shared room basis for nights one and two during the Event. Due to limited availability, this will include a mixture of single, twin, triple and quadruple rooms, as well as a small number of glamping pods, at a number of locations. Should participants book in groups, we will endeavor to place participant groups together for accommodation where possible, however, we cannot guarantee this as the accommodation provided will be split over numerous accommodation locations/styles;
 - ii) accommodation will be provided on a dinner, bed and breakfast basis. It is the participants’ responsibility to advise us of any special dietary requirements. We will advise the accommodation/food provider of any such requirements but we cannot guarantee compliance; and
 - iii) a limited number of snacks and drinks at various support locations throughout the duration of the Event.
- (f) It is the responsibility of each participant to supply any additional food and drink beyond that which will be supplied as part of the Event.
- (g) Celtic FC Foundation may at any time and at its sole discretion, cancel the Event, withdraw your place on the Event or exclude you from the Event. If the Event is cancelled (and not rescheduled) or Celtic FC Foundation withdraws your place on the Event or excludes you from the Event, Celtic FC Foundation will, on receipt of request from you, refund to you any sums received from you (including your entry fee).

2. Personal, Medical and Insurance Requirements

- (a) You must be 18 years of age or over on Thursday, June 9, 2022 in order to sign up and participate. There is no maximum age for participation but the Event is exceptionally physically challenging.
- (b) You are required to bring and wear sensible clothing and footwear. Celtic FC Foundation and its Delivery Partners will be pleased to advise you about the most suitable clothing and footwear at our first remote meeting.
- (c) You must comply with any training, conditions and health and safety instructions provided to you throughout the duration of the Event by Celtic FC Foundation and/ or the Delivery Partners.

Mary’s Meals is a registered Scottish Charitable Incorporated Organisation, number SC022140.

- (d) The Event is a physical challenge and is not without risks. You must be adequately fit to undertake the Event. In addition, you agree to pay Celtic FC Foundation in regard to any claims for loss or damage to personal property or for losses or claims through your participation in the Event arising from your own actions. You will not participate in the Event unless you are in a good state of health at the time and are not suffering from any medical condition or disability that might make it unsafe for you to participate in the Event.
- (e) You will make sure that to the best of your knowledge and belief you are in the appropriate physical condition to participate in the Event. Participants shall not participate in the Event if it would be medically unsafe for them to do so.
- (f) **Celtic FC Foundation shall not take any steps to ensure that you are in the appropriate physical condition to participate in the Event. You must seek medical advice from your doctor if you are in any doubt as to your physical ability to participate in the Event.**
- (g) Prior to and during the Event, you are responsible for your own medical condition(s) and health and safety to allow you to participate in the Event.
- (h) You may be required by Celtic FC Foundation to complete a Participant Waiver and Release Form on arrival at Celtic Park on Thursday, June 9, 2022.
- (i) Celtic FC Foundation will have no liability for any risk, loss or costs which you incur in connection with the Event, though nothing in these terms will exclude or limit the liability of Celtic FC Foundation for death or personal injury caused by our negligence. If you require Personal Accident or Medical Insurance in order to participate in the Event, it is your responsibility to arrange this or any other necessary insurance in connection with the Event. Celtic FC Foundation will not carry any insurance in relation to your participation in the Event.
- (j) You must comply with any instructions provided to you on the day by Celtic FC Foundation or its Delivery Partners.
- (k) Celtic FC Foundation hereby reserves the right at its sole discretion not to allow you to participate in the Event if Celtic FC Foundation and/ or the Delivery Partners consider that your participation in the Event would affect your safety or enjoyment or the safety or enjoyment of other participants in the Event.
- (l) Participants aged 70+ must also have the Medical Advice Form completed by a doctor.

3. Availability

- (a) There are a limited number of places available for the Event. Places will be allocated on a first come, first served basis, based on the entry fee being processed and agreement to the terms and conditions.
- (b) Celtic FC Foundation reserves the right to cancel, alter or delay the Event as a result of any unforeseen circumstances beyond the reasonable control of Celtic FC Foundation including, but not limited to, adverse weather conditions. If cancellation, alteration or delay of or to the Event occurs, then Celtic FC Foundation will advise you as soon as it is reasonable to do so.

4. Registration and Sponsorship

- (a) You must pay a non-refundable registration fee of £50.00 per participant, through the online registration page provided. This registration fee will not be refunded if you withdraw or fail to participate in the Event.
- (b) You must provide the details requested, which include an emergency contact name and telephone number of someone who will be available during the Event. This must not be another participant in the Event.

- (c) In order to pay the entry fee, you will be transferred to EventBrite's website. Please note that Celtic FC Foundation does not have any control over EventBrite's website and your use of, and interaction with, EventBrite's website is subject to EventBrite's website terms and conditions. Celtic FC Foundation excludes liability for any damages, losses, costs or expenses relating to or arising from your use of, or interaction with, the EventBrite website.
- (d) The closing date for entries is Monday May 23, 2022, subject to availability.
- (e) Should you have an outstanding sponsorship balance from a previous Celtic FC Foundation event, this must be settled in full prior to registering for this Event or your registration will be suspended pending full payment of the total due.
- (f) In order to participate in the Event, you must raise a minimum of £250.00 in sponsorship. This is over and above your entry fee of £50.00.
- (g) On receipt of your booking form and entry fee, Celtic FC Foundation will provide email confirmation of your entry plus a paper sponsor form and guidance to allow you to set up an online fundraising page. You must not carry out door-to-door or street collections or produce any printed materials featuring Celtic FC Foundation unless you have first sought the permission of Michael McCourt at Celtic FC Foundation, who can be contacted at cfcfoundation@celticfc.co.uk.
- (h) At least 50% of the minimum fundraising requirement of £250.00 must be paid at least two weeks prior to the Event, by Thursday, May 26, 2022.
- (i) Monies raised online through Just Giving will transfer directly to Celtic FC Foundation.
- (j) You must send Celtic FC Foundation your paper sponsorship form, if applicable and balance of sponsorship money within two weeks of the Event, by Thursday, June 23, 2022.
- (k) You must pay all of your sponsorship money to Celtic FC Foundation, even if you do not participate in the Event.
- (l) Celtic FC Foundation hereby reserves the right at its sole discretion not to allow you to participate in the Event if you fail to make payment as required in Clause 4(h) and/ or 4(j) above.
- (m) While obtaining sponsorship money and taking part in the Event, you must not do anything to bring Celtic FC Foundation, Celtic Football Club or the Delivery Partners into disrepute.
- (n) You must comply with all relevant legislation when fundraising for the Event.

5. Photography/ Images

- (a) Any photographs or footage taken of you during the Event may be used by Celtic FC Foundation, Celtic Football Club and Mary's Meals without charge in all media (including all Celtic FC Foundation social media channels) for promotional purposes. This includes but is not limited to, use in promotional and publicity materials (both printed materials and those featured in the Celtic FC Foundation and Celtic FC websites) for future events hosted by Celtic FC Foundation.
- (b) Your acceptance of these terms and conditions will be deemed as the giving of your consent for this purpose.

6. Governing Law and Jurisdiction

These terms and conditions are governed by Scots Law and any dispute in relation to them is subject to the exclusive jurisdiction of the Scottish courts.
