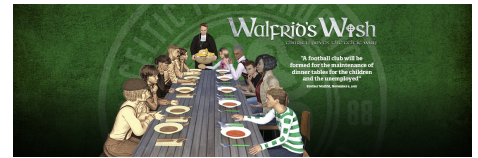

## GIFT AID DECLARATION
